- S, R, O, No. 33-/-In exercise of the powers conferred by section 87of the Food Safety Act 2013 (Act No. 43 of 2013), to be read with section 13 (4), the Bangladesh Food Safety Authority, with the priorapproval of the Government hereby enacted the following Regulation, as follows: -
- 1. Title and introduction. (1) these regulations shall be known as The Food Safety (Sample Collection, Testing and Analysis) Regulations, 2023.
- (2) These regulations shall come into force forthwith.
- 2. Definitions. (1) In this Regulations, unless there is anything repugnant in the subject or context,
- (a) "Act" means the Food Safety Act, 2013 (Act No. 43 of 2013);
- (b) "Responsible officer" means any officer empowered by the authority for the prescribed jurisdiction;
- (c) "Schedule" means any Schedule to these Regulations;
- (d) "Sample" means a representative portion/unit of food or foodstuff collected for testing and/or analysis;
- (e) "Sample code" means the specific code used in the sample;
- (f) "Sample container" means any such container used for collection of samples, which is free from any contaminants, , migration free, non-absorbent, dry and inert with the sample;
- (g) "Sample Collector" means food safety inspector or any person authorized by the authority, who collects samples for testing and/or analysis;
- (h) "Sample Provider" means any person/organization or food business operator or representative, who sells or surrenders samples on demand of the sample collector;

(h)

- (i) "Test" means any necessary physical, chemical, microbiological and other necessary tests on food or foodstuffs in food laboratory;
- (j) "Form" means any form specified in Schedule-1;

- (k) "Food laboratory" means any laboratory or establishment where food is tested, by whatever name called, established under any law or recognized by the Government.
- (l) "Result Analysis" means testing of the food or foodstuff and a thorough analysis of the results obtained; and
- (m) "Certificate" means the report of the food analyst containing the testing and analysis result of samples;
- (2) All words or expressions used in these Regulations but not defined or explained shall have the same meaning as they have in the Act.
- 3. Collection of samples.—(1) For the purpose of execution of duties of the Authority, sample collector when suspects or has reasonable cause to believe that any food or foodstuff contains any contaminant, adulterant or substance injurious to human health or if the food or foodstuff is considered to be unsafe, sample collector shall collect adequate quantity of sample for testing purpose in the laboratory or quantity of samples specified in schedules 2 of the concerned food stuff or foodstuff for testing and analysis, on payment of the price.
- (2) The sample referred to in sub-clause (1) may be collected from any place of the food supply chain including production, transport, sale or storage and the person who is in possession, he shall be bound to sell on payment of the price or, as the case may be, surrender the said sample.
- (3) In the case of the collection of samples under these regulations, the sample collector shall record the matter in Form-1, in which the signature of at least one witness and the signature of the person providing the sample or as the case may be thumb impression of that person, shall be taken on the declaration of sample provider:

Provided, however, that if the sample provider refuses to sign the acknowledgment declaration or to give the thumb impression, the matter shall be recorded in the form.

- (4) In case any sample is to be collected from any open container, in that case the sample is to be collected from the bulk container.
- (5) Any person may, subject to the provisions of section 46 of the Act, undertake to test or analyze a sample of food or foodstuff on his own initiative.
- **4. Division and distribution of samples.** (1) after the collection of samples in accordance with the provisions of regulation 3 the sample collector shall divide the sample into 4 (four) parts in the presence of the sample provider:

Provided, however, that in case of any packaged food or foodstuff, 4 (four) samples of the same lot shall be taken.



- (2) 4 (four) parts of the sample shall be kept in 4 (four) separate sample containers by labeling them with the necessary identification sample code for each part and the containers shall be sealed or made tamper-proof, and the following measures shall be taken:-
- (a) 1 (one) part to be provided to the sample provider;
- (b) 1 (one) part, for the purpose of future comparison, shall be sent to the officer in charge or the responsible officer for preservation in the proper place and procedure as may be directed by the authority, from time to time, depending on the type of the food; and
- (c) the remaining 2 (two) portions immediately sent to the Food Analyst of the jurisdiction concerned.

Provided that in case of sample collected for microbiological analysis, the Food Safety (Determination and Control of Microbiological Contaminants) Regulation, 2023 shall be followed.

- (3) If the sample is collected from the original container in accordance with sub-regulation (4) of regulation 3, it shall be divided accordance with sub-regulation (4) (2) and shall also be sent for testing or analysis in accordance with the provisions of this Regulation.
- (4) If a food court under section 50 of the Act orders any sample to be tested or analyzed, unless otherwise directed by the food court, the authority shall collect the relevant sample in accordance with the provisions of these regulations. After collecting the relevant sample and analyzing the sample, the authority shall direct any of his officers or inspectors to make necessary arrangements to submit the report to the food court.
- (5) If any sample is sent to any food laboratory for testing or analysis as per the directions of the Court, the concerned laboratory authority shall immediately send a report in Form-2 for the information of the Court:

Provided that if any sample obtained is unsuitable for testing or analysis or there is any other reasonable limitation, it shall be recorded in the said form and informed to the concerned Food Court.

- 5. Use of sample containers. (1) After collecting the sample, it shall be kept in the sample container, so that the quality of the sample remains accurate and unchanged during its storage or transportation.
- (2) During the collection of samples, the sample collector shall be cleaned and the equipment, tools and containers used in the collection of samples shall be used with the highest standards of cleanliness, maintenance and caution, so that the quality of the sample remains accurate and unchanged.
- (3) Samples collected from wrapped or open containers for sample testing or analysis, according to the type of sample and the desired test conditions, must be kept and sealed in the sample container in such a way that the quality of the sample in the sample container remains unchanged, ensuring the appropriate temperature and environment.




- **6. Sample storage method.** (1) Every sample should be preserved in a proper manner and environment, taking into account the nature and characteristics of the original food or foodstuff, the wrapping and container of the sample, so that its quality remains unchanged.
- (2) In the case of sample storage, normal temperature and pressure and, as applicable, controlled temperature and pressure shall be ensured, taking into account the nature and characteristics of the sample concerned and the geographical and local weather.
- (3) Samples shall be stored in a suitable place of any government institution; however, if necessary, suitable premises of any semi-government, autonomous, or private institution may also be used for storage of samples:

However, it is provided that before sending the sample, it is necessary to confirm the sample storage system by contacting the concerned institution, and at the time of sending the sample, the request for the sample storage shall be notified to the said institution by filling Form-3.

- (4) After receipt of the sample, the receiving institution of the sample shall inform the sender about the receipt and the existing condition of the sample as per Form-4.
- (5) After receiving the sample, the sample-receiving institution shall take measures to preserve the sample by ensuring a proper environment for the sample.
- (6) In general, no sample will need to be preserved for more than 3 (three) months, however, the sample obtained in the context of the case shall be preserved until the relevant case is settled or until the Food Court gives a different instruction.
- (7) The authority shall issue notification in the gazette after selecting suitable public and private institutions for preservation of samples.
- 7. Sending sample to food analyst.—(1) 2 (two) portions of the split sample with two separate memos (challan) in accordance with the provisions of sub-regulation (2) of regulation 4 shall be sent, as soon as possible, to the food analyst of that jurisdiction where the sample is collected.

Provided, however, in special cases and in the interest of ensuring safe food, the sample shall be sent to any food analyst, food laboratory, or organisation with a notification to the respective food analyst of that jurisdiction.

- (2) While sending any sample mentioned in sub-regulation (1) to the food analyst, the necessary information shall be informed by filling out Form-5 along with the sample.
- (3) If any person, subject to the provisions of section 46 of the Act, voluntarily collects a sample for the purpose of testing or analysis, he shall on his own initiative send the said sample to the food analyst of the concerned jurisdiction.



- (4) Each sample shall be sent by registered post, by hand, in a safe conveyance, or, as the case may be, in such other manner as may be directed by the Authority in the interests of controlling the temperature and pressure necessary for any sample of a particular nature, taking into account that the quality of the sample remains accurate and unaltered.
- 8. Responsibilities of Food Analyst——(1) after receiving the sample, the Food Analyst shall follow the following procedure for test and/or analysis,:-
- (a) 2 (two) Parts of the sample containing the letter, label, seal, sample code, signature and phone number of the sender and the integrity of the sample container shall check and record and if any deviation is observed, record and clarify the deviation by contacting the sender.
- (b) If any of the 2 (two) samples is found to be unfit for testing or analysis, shall record and arrange for the other sample to be tested or analyzed after notifying the sender;
- (c) If two (2) samples appear unfit for testing or analysis, shall record and notify to the sender's office without any delay;
- (d) Acknowledgment of receipt of the sample to the consignee as per Form-6 and if the sample is not amenable to testing or analysis shall also be mentioned therein; and
- (e) Destroy unfit samples as per Standard Operating Procedure (SOP)
- (2) The officer sending the sample, if notified under sub-regulation (1) that any sample is unfit for testing or analysis, shall re-send the other part of the sample in his custody to the Food Analyst for further action in appropriate procedures.
- (3) The Food Analyst shall, after duly taking the sample, arrange for the testing or analysis of the sample and follow the best practice or standard procedure in testing or analyzing samples and shall, where applicable, perform the duties as directed by the Court.
- (4) The Food Analyst shall, satisfactorily perform such other duties as may be assigned by the Authority; and complying with all instructions given by Government and authorities in respect of sample testing or analysis.
- **9. Food laboratories, etc.** (1) To fulfill the purposes of the Act, samples of food or foodstuffs shall be sent to a food laboratory for testing or analysis.
- (2) Food laboratories and their food testing methods shall be of international standards.
- (3) The authority shall prepare a list of recognized food laboratories, detailing the overall activities of each food laboratory, the capability of testing or analyzing samples of food or foodstuffs and cooperation and coordination with various laboratories and food control agencies.



- (4) The following conditions shall be fulfilled in determining the quality of food laboratory and its sample testing and analysis,:-
- (a) Assessed and recognized by the Bangladesh Accreditation Board or any international accreditation authority or organization or government;
- (b) Sufficient number of qualified and experienced trained staff;
- (c) Appropriate infrastructure, equipment, reagents and experts;
- (d) Laboratory having Quality Assurance System to ensure good and reliable results in analysis or testing.
- (5) The Authority may, from time to time, issue guidelines containing methods of testing or analysis of food.
- (6) If the method of analysis or testing of any sample of food or foodstuff is not specified in the guidelines issued under sub-regulation (5), the method approved by any international organization in this regard shall, with due cause, be followed.
- 10. Analysis of test results. ——(1) Food Analyst, in general case, within 07 (seven) working days and in case of emergency, within 03 (three) working days from the date of receipt of sample shall issue test report.
- (2) In the case of any sample test or analysis as directed by the Court, the sample analysis or test shall be completed within the time limit specified by the Court and the report along with the certificate shall be sent to the concerned Court:

Provided, that if, for any valid reason, additional time is required, an application for extension of time shall be made to the Court before the expiry of the directed period.

11. Issuance of certificates, etc. — (1) On the basis of the results of sample testing or analysis Food Analyst, in accordance with "Form-7", shall prepare 4 (four) sets of certificates and shall preserve 1 (one) copy in the office, send 1 (one) copy to the authority,1(one) copy to the responsible officer and 1(one) copy the sample sender.

Provided, that in case of testing or analysis of any sample under the direction of the Court, a separate report shall be prepared on the basis of the relevant certificate and sent to the concerned Court along with the certificate:

Provided further that, after obtaining the certificate of sample testing or analysis, the concerned sample collector shall send a copy of the certificate to the sample provider.

(ii) any certificate of sample testing or analysis will not be accepted without the seal and signature of the Food Analyst of the jurisdiction concerned.



- (3) The utmost confidentiality shall be maintained in all cases from the receipt of the sample to the issuance of the certificate, and in any case where there is a danger of the confidentiality being leaked, the food analyst, in cooperation with the authority, shall take measures to resolve it. -
- (4) The food analyst shall take measures to keep the soft copy of the information related to the analysis or testing of each sample in the computer database and he shall take the cooperation of the food laboratory in this activity.
- (5) Hard copy and soft copy of data relating to food analysis or testing in every food laboratory shall be retained for such period as may be directed by the Authority.
- (6) The Authority shall, by notification in the Gazette, inform all concerned about the retention, storage and exchange of information relating to food testing or analysis and other necessary issues.
- 12. Actions to be taken after obtaining the certificate. (1) If it is evident that the food or foodstuff of the relevant sample is not safe, the food officer of the concerned jurisdiction or the inspector on his behalf shall take legal action against the concerned food business operator.
- (2) If it is mentioned in the certificate obtained in accordance with the provisions of section 46 of the Act that there is an excessive amount of contaminant or adulterant or any substance harmful to human health in the sample, the concerned person shall inform the matter to the authority, the Food Officer or Inspector to take necessary legal action against the concerned food business operator, along with the copy of the certificate.
- Provided that if any information is given under this sub-regulation, the identity of the person giving the information shall be kept confidential.
- (3) Notwithstanding anything to the contrary contained in these Regulations, as part of market surveillance, any establishment or organization may, as directed by the Authority, immediately collect samples of food or foodstuff from any place for preliminary testing by mobile or any other food laboratory; if an excessive amount of contaminant or adulterant or any substance harmful to human health is observed in the result obtained, it shall recommend to the authority to take legal action based on the result.
- (4) The food officer shall preserve the samples kept in his custody for a period of 3 (three) months or, if it is related to a case, until the case is disposed of or until the Food Court orders otherwise, but in case of necessity, it may be preserved for a longer period.
- 13. Defense of the aggrieved party.—— (1) If any person or party is aggrieved by the result of the sample test or analysis of any food or foodstuff, he may, within 15 (fifteen) days of being informed of the matter, may defend himself and apply to the authority for reconsideration.



- (2) If any application is made under sub-regulation (1), the authority shall, within 15 (fifteen) days of receipt of the application, give its decision on the matter concerned and the decision shall be deemed final.
- 14. Power to amend schedule.— The Authority shall, with the prior approval of the Government, reserve the power to make necessary amendments, alterations and additions to the Schedule and may publish the same for public information by notification in the Gazette.
- 15. Removal of ambiguity.— If any ambiguity arises in carrying out any provision of these Regulations, the Authority may, in consultation with the Government, remove such ambiguity by notification in the Official Gazette, subject to conformity with these Regulations.
- **16. Inapplicability.**—All the provisions of the Pure Food Rules, 1967 which relate to the provisions of these Regulations shall cease to apply as soon as these Regulations come into force.
- 17. Publication of translated texts in English. —— After promulgation of these Regulations, the Authority may, if necessary, with the prior approval of the Government, by notification in the Official Gazette, publish an authentic English text of these Regulations:

Provided, that in case of conflict between the Bengali and English texts, the Bengali text shall prevail will get.
