# **Terms of Reference (TOR)**

## **for**

### **Production of Food Safety Awareness TVC**

#### **Background of the Project:**

To ensure the rights of safe food and protect public health of the people of Bangladesh, revolutionary Food Safety Law, 2013 had been passed in the national parliament by the visionary and sensible decision of the Honorable Prime Minister Sheikh Hasina. Also this law is introduced to establish an effective authority for food safety. Government has established 'Bangladesh Food Safety Authority' (BFSA) on 02 February 2015 under the Food Safety Law, 2013, which has been functional since 01 February 2015.

Bangladesh Food Safety Authority already launched its field level operation to 64 districts. Due to the lack of development projects, BFSA authority could not improve the service and activity to its expected standard in the last 06 years of its launch. Because of the following activities including- inspection/monitoring, testing laboratory for identification of contamination in food, mobile laboratory and lack of database for food businesses and monitoring and evaluation activities in food management, BFSA could not reach its goal to the prospective stage.

The main objects of this project is to assist in establishing an effective and skilled food safety authority. Part of the digitalization process, following actions is necessary- initiate robust field surveillance activity by establishing mobile laboratory and to reach that goal train human resource to improve their skill, organize workshop, seminar and rally to create awareness regarding food safety among general people, advertisement on electric and print media, set-up permanent digitalized advertisement board, routine monitoring of food management organization and food businessman to prevent contamination in food, digitalizing inspection system and form online complaint management system, prepare database for food inspector, food businessman and food business organizations, provide training to personnel related with food production and food businesses.

1. **Overall objective of the project:** To strengthen the capacity of Bangladesh food safety authority in order to ensure safe food for all citizens of Bangladesh.
2. **Specific Objective of the activity:** To raise awareness through media mobilization for information and knowledge about food safety at grass root level among much people.
3. **Project Period:** 01<sup>st</sup> July 2021 – 30<sup>th</sup> June 2025
4. **Project Location:** All over the Bangladesh.
5. **Target Group:** All citizens of Bangladesh.
6. **Scope of Work:**
  - a) Production of Food Safety Awareness TVC in Bangla (Probable number 5).

## 7. Detailed scope of work:

- a) Each Television Video Clip (TVC) duration will be 13 to 60 Second or nearer.
- b) Theme/Concepts for TVC: Food Safety Awareness (To be detailed in RFP).

## C. Description of Tasks:

The consulting firm is required to undertake the following tasks for the production of TVC.

- 1) To prepare the concept/contents script and use other relevant reference materials as required.
- 2) Submission of development process (Script writing, recruitment of Artists, Film sharing, Editing, etc) of TVCs.
- 3) Get approval of the concept/script from Project Director before developing TVC.
- 4) Production of TVC.
- 5) Presentation of TVC (draft).
- 6) Final Presentation of TVC.
- 7) Final Production with all incorporation.

## D. Requirements:

- a. The firm must have;
  - (1) Up to date valid Trade license.
  - (2) Tax Identification Number (TIN) with tax clearance Certificate for the latest fiscal year.
  - (3) VAT Registration Number.
  - (4) Financial Solvency certificate from any Scheduled Bank.
  - (5) The consultant/Consulting firms have to provide one completed work in the form of Google drive link/Pen Drive/DVD along with Completion Certificate.
- b. The firm/company must be a TV spot/video documentary production house/company having full shooting facilities with technical capabilities.
- c. Consulting firms should submit their company profile along with incorporation certificate of registration.
- d. The expression of interest with valid company seal and signature should be submitted to the project director's office by 03 April 2023 no later than 12:00 pm.
- e. Project will evaluate the proposals as per the procurement rules and award the assignment based upon technical and financial feasibility. Only the successful applicant will be contacted for further process.
- f. Experience in making Video spot/Awareness TVC etc for Government organization will be considered as an added advantage.
- g. The company must have substantial TV spots/documentary/multimedia production related 5 years of experience.
- h. Team leader and Key members must have appropriate adequate experience with similar Video production related activities.
- i. The Firm should submit work plan, methodology, time frame with their proposal.

## E. Other related document:

- Brochure of the firm should be submitted.
- Must follow the rules of National Broadcasting Policy, 2014 and international broadcasting standard.
